RELEASE AND WAIVER OF LIABILITY AGREEMENT FOR CHEERLEADING

In consideration of allowing my child to participate cheerleading and tumbling programs and related cheerleading activities offered by Cheer Central, Inc., the undersigned, for himself/herself, his/her personal representatives, heirs and assigns agrees:

I consent to have my child participate cheerleading programs and related tumbling and cheerleading activities offered by Cheer Central, Inc. I fully understand that there is an inherent risk of injury in the sports of cheerleading and their related activities. This release is valid for any and all classes, programs, events, and other related activities my child participates in, held at, or sponsored by Cheer Central, Inc.

Cheer Central, Inc. provides cheerleading instruction for children. Instruction takes place on equipment designed for gymnastics and cheerleading. As an extension of tumbling and cheerleading classes, participants may take part in "open gyms," special day camps, parties, special events, demonstrations, and other related activities.

Should my child be injured while participating in cheerleading or tumbling activities, I give my consent and authorize employees/ independent contractors of Cheer Central, Inc. to administer emergency first aid required and to obtain medical attention including transportation by ambulance if the employee/independent contractor deems it needed.

I and my child fully understand that cheerleading and tumbling activities involve motion, rotation, and height, in a unique environment, and as such, carry with them an assumption of risk. I and my child hereby assume full responsibility for and risk of bodily injury, death or property damage due to negligence of Releasees (as defined below) or otherwise, while in or upon Cheer Central's facilities for any purpose including training, competing, observing, working or participating in activities. There are risks and dangers associated with participation in cheerleading and tumbling including, but not limited to those of bodily injury, partial and/or total disability, paralysis, death and property damage. All of the risks and dangers associated with participating in the activities held at, or sponsored by, Cheer Central, Inc. are assumed notwithstanding.

I and my child hereby forever and fully release, waive, discharge, indemnify and agree to hold harmless Cheer Central, Inc., a Colorado corporation, and its officers, directors, stockholders, employees, agents and independent contractors (each a "Releasee" and collectively the "Releasees"), from and against all claims, demands, causes of action and liability of every type and kind and nature whatsoever, for damage, loss, injury or death to any of myself and my participating child, or to any of my property or property of my child which results from participation in activities held at, or sponsored by, Cheer Central, Inc., whether such claim, demand, cause or action or liability is based upon negligence, breach of warranty (expressed or implied), breach of contract (expressed or implied), product liability, or upon any other legal theory or basis of any nature whatsoever.

I hereby agree that this Release and Waiver of Liability Agreement is intended to be as broad and inclusive as is permitted by the law of the State in which my child participates in activities at, or sponsored by, Cheer Central, Inc. and that if any portion hereof is held invalid, it is agreed that the balance shall continue in full force and effect.

This Agreement is a legally binding contract and supersedes any other agreements or representations by and between these parties, written or oral, with regard to the subject matter hereof. This document is intended to be a full, general, and comprehensive release of liability.
