I fully understand that Premier Athletics staff members are not physicians or medical practitioners of any kind. Students may suffer injuries, possibly minor, serious or catastrophic in nature. These activities can be dangerous and can lead to injury!

Parents should make their children aware of the possibility of injury and encourage their children to follow all the safety rules and the coaches' instructions.

Premier Athletics, its coaches and other staff members, will not accept responsibility for injuries sustained by any student during the course of tumbling, stunting, cheerleading, camps or clinics in which he or she may participate or while traveling to or from the event.

With the above in mind, and being fully aware of the risks and possibility of injury involved, I consent to have my child or children participate in the programs offered by Premier Athletics. I, my executors or other representatives, waive and release all rights and claims for damages that I or my child may have against Premier Athletics and or its representatives whether paid or volunteer.

I also affirm that I now have and will continue to provide proper hospitalization, health and accident insurance coverage which I consider adequate for both my child's protection and my own protection.

I also understand that it is the parents' responsibility to warn the child about the dangers of cheerleading and injury. The parent should warn the child according to what the parent feels is appropriate. Premier Athletics will only warn the child through "Safety Messages" and our teaching style and progressions.
