

Maine Event Cheer & Training Center Release Agreement

Please read carefully before signing

1. In consideration of the Participant named below being permitted to participate in tumbling classes of or related to the Maine Event Cheer, the participant named below either individually or in the case of a minor by and through his or her legal guardian(s) understand, acknowledge and agree that:

a) There are risks and dangers inherently associated with participation in tumbling as with any athletic event and activities could result in bodily injury, partial and/or total disability, paralysis and death. The social and economic losses and/or damages could be severe. These risks and dangers as well as other risks, not contently known to US and/or not foreseeable at this time may be caused by the action, inaction or negligence of the Participant or the action. Inaction, rescue attempts or procedures, or negligence of others, including, but not limited to the Releases named below;

b) The Participant, or if the Participant is a minor, the parent and/or legal guardians of the minor Participant shall inspect the facilities and equipment used in any tumbling class and if he or she believes anything is unsafe, shall immediately advise Maine Event Cheer of such condition and refuse to participate or if the Participant is a minor, refuse to have the minor Participant participate; and

c) Recognizing the risks and the right to refuse 10 participate. the Participant (and if the Participant is a minor, we the parent(s) and/or legal guardian(s) on behalf of the minor Participant or the Participant's behalf of the heirs, persona! representatives, successors, and assigns of the Participant), fully accept and assume the risks and responsibility for any and a" losses and/or damages arising from or related to such injury, disability, paralysis or death, however caused and whether caused in whole or in part by the negligence of the Releases named below and accordingly HEREBY RELEASE, WAIVE, DISCHARGE Maine event Cheer & Training Center, its owners, officers, managers, coaches, employees and agents, (herein the "Releases"), FROM ANY AND ALL LIABILITY TO THE PARTICIPANT and the Participants personal representatives, assigns, executors, heirs and next to kin for any and all claims, demands, losses or damages and any claims or demands actions, suits, debts, controversies. claims, and demands whatsoever arising from or related to any injury, including but not limited to the death of the Participant or damage to property, arising out a or relating to Maine Event Cheer & Training Center activities caused or alleged to be caused in whole or in part by the negligence of Release the actions or inactions for the Releases or for any other reasons(s). I//WE further expressly agree that this Release is intended to be broad and inclusive as permitted by the law of the State of Maine and any other Province or State in which Maine Event Cheer & Training Center activities may be conducted and that if any portion thereof is held invalid, it is agreed that the balance of the Agreement shall continue in full legal force and effect.

2. This Release is binding on the undersigned Participant and their respective personal representatives, assigns, executors, heirs, next of kin, insurance companies, attorney's and agents.
