I authorize, without compensation Cheer USA Championships, its successors, assignees, licensees, sponsors, any television networks and all other commercial exhibitors the exclusive right to photograph, publish, reproduce, record, and use, with or without my name or the name of the person for whom I am the parent/guardian.
