I understand and agree that the cheerleading uniform being rented is the property of the Clearwater Jr. Tornadoes (CJT). This uniform is being issued to my child for use during the playing season of \_\_\_\_\_. I also accept responsibility that the uniform will be returned in the same condition as when issued, except for normal wear and tear.

By signing below, I accept responsibility to insure that the uniform rented to my child for her use during the cheer season will be returned after the SYFC Cheer Competition. If my child is absent from the organization for longer than a week and/or withdraws from the organization for whatever reason, I am responsible for returning the uniform within ten (10) days to the CJT office or paying a \$150 uniform fee per cheerleader. It is also understood that my child **MUST** be signed off on the equipment list by a Board Member when returning this uniform or CJT has no proof that it was actually returned and is not liable.

I will also take care of this uniform which includes proper laundering (where applicable). If while in our possession, this uniform becomes stolen, destroyed or unusable through negligence on our part, I agree to reimburse the Clearwater Jr. Tornadoes (CJT) the determined cost to replace such item(s). Lost uniforms **MUST** be paid for prior to having it replaced by the equipment room.

Furthermore, I understand and agree that in the event the above uniform is not returned or the replacement fee is not paid, I will not be able to register my child with the Clearwater Jr. Tornadoes (CJT) and/or any organization within the SYFC for the next playing season until the above matter has been satisfied.

If uniform is not returned as outlined above, the following actions will be taken:

1. A CJT representative will call your residence two times notifying you of an arranged time you can drop the uniform off to the CJT Office.
2. After failure to return the uniform after phone calls, you will receive a registered letter in the mail notifying you to return the uniform on a said date.
3. After ten (10) days of the registered letter being sent, if said uniform is not returned by specified date, a complaint for Theft by conversion, in accordance with Florida Statute 812.014, will be filed with the Clearwater Police Department for full prosecution. You will be liable for any costs.

Uniforms shall not be issued until ALL Clearwater Jr. Tornadoes and SYFC registration requirements have been satisfied and released by the registrar.
