Integrity All Stars Cheer & Dance understands competitive cheerleading can be an expensive sport. You, as parents, are making great sacrifices in order for your athlete to be able to participate in this wonderful sport. It is critical that all families committing to our program completely understand the financial commitment they are making. For 2009-2010, we have set a fixed cost of \$_____ for monthly tuition payable starting in July up to and including April. Your monthly fee will include cost of equipment, music, facility expense, and etc. This is an attempt to make the financial side of this commitment as easy for you to understand and plan as possible. We hope this will simplify your financial planning. In addition to the annual registration fee which is due upon your child being placed on the team, there are also uniform rental, accessories, and competition fees which will be of extra costs.

All travel expenses and entry expenses to the National Competitions are not covered in tuition fees. You are responsible for those traveling costs.

Program Rules and Regulations

This is "Competitive Cheerleading"

As a participant of Integrity All Stars Cheer & Dance, you are expected to attend all practices, exhibitions, and competitions as a team. Your routines are coordinated around every team member therefore; one member's absence has a negative impact on the entire team. Be prepared to rearrange your schedules as needed however we will try and maintain a routine schedule in order for you to be able to make advance personal plans. There are NO EXCUSED absences from competitions.

Excused absences for practice are as follows:

- Death in family
- Family wedding
- Pre approved absence notification
- Contagious illness

Unexcused absences for practice are as follows:

- Non contagious illness (injury that you can attend practice and not able to participate)
- Optional activities (including school activities that are optional and do not affect your grades)
- Birthday parties
- Transportation Issues (we have a set schedule so you should be able to plan to have transportation)
- Homework or tests (please plan efficiently)

Proper attire will be worn at ALL practices and competitions!
Sneakers must be worn, flyers MUST wear cheer shoes at every practice and competition
Hair must be kept out of your face
Fingernails need to be kept trimmed (it really hurts to get cut with them)
No jewelry at practices or competitions
All cheerleaders (excluding males) must wear bloomers at all practices and competitions.

Material, Uniform & Property Rights Agreement

1. Integrity All Stars Material Agreement:

As a member of Integrity All Stars Cheer & Dance, any material (cheers, chants, pyramids, partner stunts, transitions, dances music, routines, etc.) may not be used or taught for any purpose to anyone outside the Integrity All Star Cheer & Dance program. All material is owned by Integrity All Stars and may not be reproduced, downloaded, or taught in any manner without prior written consents from the staff of Integrity All Stars. Anyone violating this agreement may be expelled immediately and pay full contract fee at the time of the violation to Integrity All Stars Cheer & Dance.

2. Integrity All Stars Uniform Agreement:

Any and all parts of the Integrity All Stars uniform may only be worn during specific official Integrity events (excluding warm up jackets). The uniform may not be worn for any other activity without prior written consent from the Integrity All Stars staff. Anyone violating this may be expelled immediately from the Integrity All Stars Program. Your Integrity All Stars Cheer & Dance uniform will remain property of the Integrity All Star Program until you pay the balance of the uniform fee during the course of the season or after your ONE Year commitment to the program. If you terminate your relationship by quitting or via dismissal, you will be required to return your uniform within one week of quitting/dismissal. Loss or damage of any leased uniform will be charged \$300.00 in full. Payment needs to be received within one week or you will be obligated to pay full court costs.

3. Integrity All Stars Property Rights Agreement:

NO Integrity All Stars related items may be sold without prior written consent from the Integrity All Stars Cheer & Dance staff. The company names and it entity are solely owned by Integrity All Stars Cheer and Dance. Any violation of this agreement may result in legal action.
