PAYMENT POLICIES:

- Cash, Visa, MasterCard, Discover , Debit Cards and Checks payable to Cheer University LLC are accepted.
 - ALL STAR TEAM TUITION: Due the 1st practice day of each month.
 - TUMBLE CLASS TUITION: Due at Registration or by the first class of the session
- Tuition paid after the 10th of the month is subject to a \$20.00 late fee. There is a \$40.00 charge for returned checks.
- Payments can also be mailed to 400 Rike Drive, Millstone, NJ 08535.
- All star team Tuition will not be altered throughout the season for holidays, inclement weather, vacations, or cancellations of classes.
- No one may take Private Lessons, Open Tumble or any other additional Class/Clinic until all balances are up to date.
- No merchandise will be given out (paid for or otherwise) to customers with balances pending until accounts are brought up to date.
- FEES FOR SERVICES RENDERED ARE NOT REFUNDABLE.**

TUMBLE CLASS MAKE UPS: 2 make ups only are allowed per Tumble Class session. Any more classes than 2 missed will be forfeited.

CLOTHING: Class students should wear comfortable clothing, shorts, sweat pants and shirts can be worn. No buttons, no buckles, no jeans absolutely NO JEWELRY. Sneakers can be worn. Hair should always be tied back. **Team athletes must wear assigned practice wear.**
