Tuition and Fees Information

Upon enrolling a new student into a Carolina Crossfire Cheer program, the following fees must be collected prior to the student's first class.

1. Registration fee of \$30 (assessed annually). If you quit the program, this fee must be re-paid. X_____
2. First month's tuition (prorated depending on the start date). X_____
3. If you enroll in our automatic credit or debit card payment plan, then only the registration and first months tuition is due at the time of enrollment. If you choose not to do so, a deposit equivalent to one-month's tuition will be due at the time of sign up. The tuition deposit will be credited to your last month if we receive 30 days written notice, which is due by the 1st of the month, prior to the month you wish to drop, in order to receive full credit of your deposit. X_____

Upon enrolling at Carolina Crossfire Cheer you will be expected to pay your monthly tuition by one of two payment options.

1. Automatic debit through a credit or debit card and will be debited on the FIRST of each month.
2. Check, Money Order, or Credit/Debit Card payment. If payment is not received by the 5th of the month, you will be expected to pay a \$10 late fee and your credit card or debit card will be used to collect payment only if the bill is not paid on time.

Students with a balance after the 5th will not participate. If you wish to drop your class, a 30 DAY WRITTEN NOTIFICATION MUST BE SUBMITTED TO THE OFFICE TO AVOID LOSS OF YOUR DEPOSIT. All written notices should be given to the front office, mailed to Carolina Crossfire Cheer, or e-mailed to cheercoachcce@aol.com. Phone calls or telling a coach is NOT sufficient. Your tuition holds your child's place in his/her class. Even though we bill on a monthly basis, we will hold a place in a class for your child on an ongoing basis through the session. I understand all information and options. X_____

Refund and Credit Policies

There will be no refunds given. If you drop from the Carolina Crossfire Cheer program without giving a 30-day written notification you will forfeit your deposit if not set up on auto pay (last month's tuition) or we will charge your credit or debit card on file for auto draft. Monthly tuition is not pro-rated for holidays, since some months have five classes per month instead of four; this evens out over the year. X_____

Make-Up Class Policies

At Carolina Crossfire Cheer we understand that classes will be missed for different reasons. You may arrange to make up a class by attending a regularly scheduled class of the same level, a lower level, or Open Gym. Make ups must be completed within the same month. The following are event/holidays that we will be closed: Thanksgiving, Christmas Eve, Christmas, New Years, MLK Day, Easter, Memorial Day, Fourth of July and Labor Day Weekend etc. We will announce any closings ahead of time. Class Attire

Students need to dress comfortable for the gym so please no jewelry, baggy clothes, zippers or other items that can be dangerous for tumbling/cheerleading. Socks and tennis shoes must be worn and hair pulled back from the face. X_____
