Party Waiver: I(we) the minor's parents and party host, understand that Cheer Illinois Athletics and any and all staff members will not be responsible for any injuries sustained by my child or any of my guest while in or near the facility. I(we) understand that it is the responsibility of every participant to provide their own medical coverage in the case of injury or to assume the responsibility of payment in the event of an injury. Cheer Illinois Athletics and any staff members will not assume guardianship of a child that is dropped off at the facility without a guardian and therefore it is my responsibility to care for and/or contact the child's guardian in the event that the child becomes ill or injured. I understand that parents/ adults are not permitted to use the equipment. I(we) despite all reasonable precautions implemented for safety, am (are) fully aware of and appreciate the risks of catastrophic injury, paralysis and even death, as well as other damages and losses associated with participation in the programs or activities. I(we) knowingly and willingly assume all such risks. Consequently, I(we) hereby for myself, heirs, executors and administrators, do waive and release any and all rights and claims or damages against the owner, operators, coaches and other members of Cheer Illinois Athletics from personal injury or accident of any sort of nature suffered by me (us) or our party guests, the undersigned, by reason of participation or membership in classes, lessons or any programs or activities of Cheer Illinois Athletics.

Minor Release: I, the minor's parent and/or legal guardian and party host, understand the nature of these activities and the minor's experience and capabilities and believe the minor to be qualified, in good health, and in proper physical condition to participate in such activity. I hereby release, discharge, covenant not to sue and agree to indemnify and save and hold harmless each of the release's from all liability claims, demands, losses or damages on the minor's account caused or alleged to be caused, in whole or in part by the negligence of the "release's" or otherwise, including negligent rescue operations. I further agree that if, despite this release, I the minor, or anyone on the minor's behalf makes a claim against any of the release's named above, I will indemnify, save and hold harmless each of the release's from any litigation expenses, attorney fees, loss liability, damage, or cost that may incur as the result of any such claim.
